# Fish Like The Pros Tournament Rules



1. Pre-registration is required to fish in the tournament. Only anglers ages 15 & under are allowed to compete.
2. Fishing is allowed only from the bank in the designated fishing areas.
3. Children must cast and reel in their own fish except for the 4 & under Division and parents may assist.
4. Anglers may use live or artificial bait.
5. Fish must be caught using a fishing pole only. Anglers are allowed to use a net once fish is on hook to assist with the retrieving of the fish.
6. All fish must be weighed in on the official scales to qualify for the tournament.
7. Please weigh in fish once you catch them unless you have a means to keep them alive. The total weight of all fish caught will determine winners of the tournament per age division.
8. Parent's please assist with the safety of your children while casting and fishing in the tournament.
9. Fishing begins at 10:00am on the sound of the air horn.
10. Weigh ins end at Noon on the sound of the air horn.
11. The tournament committee has the right, at their discretion, to disqualify anyone from the tournament.
12. HAVE FUN and enjoy fishing Smith Mountain Lake.
